

What is Source Water Protection?

Source water protection: The first barrier in a multiple barrier approach to providing clean, safe drinking water








Source Water Protection Program Elements





Grasslands and shrubs 17%


Cultivated agriculture 5%

Calgary Source Water Quality

- Extensive monitoring shows:
 Bow: Excellent source water quality
 Elbow: Good source water quality
- Seasonally high turbidity, but The City's treatment plants are very good at sediment removal
- Reservoirs low in nutrients, but GR vulnerable to change



Trophic State Index: Glenmore Reservoir

Calgary Source Watershed Risks: Overview

• Comprehensive risk assessment completed in 2016

Risk = Likelihood x Consequence

Likelihood scores based on:

- Mapping vulnerable areas
- Potential hazards
 / contaminant sources
- Travel times
- Regulations & management practices




